

MUTTON BUSTIN' RULES AND INFORMATION

- Entries will be accepted in person at the rodeo grounds ticket office on the following date:
 - Monday, June 3rd 2019 from 10:00am-5:00pm
 - Entries can be emailed to info@gladewaterrodeo.com between the dates of May 27th at 10:00am and June 3rd 2019 at 5:00pm. Any entries outside those times will not be accepted.
- No child less than five (5) years of age or over seven (7) years of age – nor over 50 pounds fully clothed may participate. **NO EXCEPTIONS.** Proof of age and weight may be required.
- Committee will accept the first 80 complete applicants only or at the committee's discretion.
- Night preference (Wednesday, Thursday, Friday, Saturday) is accepted but not necessarily guaranteed.
- Entries will not be accepted without the following signed documents:
 - (1) CONTESTANT WAIVER AND RELEASE FORM
 - (2) CONTESTANT ENTRY FORM
- Entries will be finalized on Tuesday, June 4th 2018 and an email will be sent to the parent/guardian with further information and a pass for the child to enter the rodeo facility. Anyone accompanying a contestant must purchase tickets online or at the gate in order to be admitted into the rodeo facility. **ONLY THE CHILD WILL RECEIVE A FREE PASS.**

- Child and Parent/Guardian must report by **7:00pm** to the Mutton Bustin' check-in table for instruction and equipment fitting. Check-in is located at the far northwest corner behind the stands, along the fence. Check-in time will end at 7:30pm. **NO EXCEPTIONS.**
- **Mutton Bustin' will begin at 7:45pm.**
- Full face helmets and protective vests are required and will be provided by the Gladewater Rodeo Association. Gear is **MANDATORY.**
- Long sleeve shirts, pants, and closed toe shoes are required.
- Only one (1) parent/guardian will be allowed in the arena with the child. **PLEASE DON'T ASK US TO ALLOW MORE THAN ONE.**
- NO RE-RIDES!
- No ropes or spurs
- Mutton Bustin' is a judged event. Each contestant will receive points based on the length of time of his/her ride. Judge's decision is final.
- Undue roughness or poor sportsmanship will not be allowed. Automatic disqualification is at the discretion of the committee.
